

# LUNAR CONSTITUTION BILL OF RIGHTS

## PREAMBLE

We, the citizens of the planet Earth, do hereby declare our resolve to hold a dual citizenship with our mother planet Earth and the Moon of Earth. We are a strong learned group of highly developed individuals with enormous insights into the futility of government rule as we know it. With a desire and commitment to reach beyond our Terran limitations, we direct our energies and resources to developing a way of life, sharing freedom and equality with all. We applaud our differences and recognise that these qualities have given our zest for life a direction and strength unknown to our ancestors. We are reaching for our true destiny to be creatures of exploration, kindness, strength and compassion. In the creation of the governing body of the Moon we pledge to validate the true meaning of the human species. To develop relationships with our galaxy and all those entities that inhabit it. As we venture further and further in our solar system we will not lose sight of the religious freedom that is the inherent right of all of us. We will seek out life and applaud and embrace its fulfilment. With these ideals in place we pledge to be tolerant of those with ideas different than ours and to at all costs maintain the peace with one another.

## OUR MISSION

Our Mission shall be to develop a symbiotic relationship with the Moon of Earth and all life forms there. We will allow our magic to direct the child within all of us to challenge our thoughts in order to create the imagined reality of life on the Moon. We will strive to allow our pioneering spirit to direct us through all development of ourselves and the Moon communities we construct. Our quest for enhancement and improvement of the human species, the planets we inhabit, and the varied life we will encounter directs us to consider patience and tolerance while we build the worlds of our future.

## BILL OF RIGHTS

1. You have the right to be guided by your heart. To seek human dignity and honour. To pursue happiness, freedom of speech, religion, property management and ownership.
2. Your property may be utilised in the following manner:
  - A. You may rent to any being of your choice as long as they adhere to the precepts of this Bill.
  - B. You have the right to sell, consign or will your property in whole to any being you choose as long as they register their ownership with the Lunar Embassy within 30 days of their acquisition.
  - C. You are allowed to subdivide your properties to a maximum of ten times and sell, gift or will said properties to a person(s), being(s), company(s) of your choice. Any property owner subdividing more than ten times will be in violation of ongoing Ambassador licensing agreement and is punishable by revocation of property ownership without compensation.
3. You have the right to build any structure(s) that are logically conceived and built to contain the human existence away from the harshness of the Moon elements as long as such structures do not disrupt the aesthetics of the existing geography or neighbourhood.

## CONSTITUTION:

### Article 1

The Moon of Earth shall be governed, for the time being and until such time implementation of the Galactic Government is set in motion, by the combined efforts of all property owners investing their energies to create a ratified Constitution by one person hereinafter known as "The Head Cheese". This is a title claimed not earned and cannot be unclaimed. "The Head Cheese" as acting head of the Galactic Government will also carry the title, CEO (Celestial Executive Officer) and both titles will for now and until the end of time be known by the Earth name, Dennis M. Hope. This Constitution and this article will define the need for an elected democratic process allowing each property owner to be recognized as a citizen of Moon to cast one vote each towards the election of required Galactic Government officials. "The Head Cheese, CEO," shall be consulted on all matters of change to the Constitution/Bill of Rights and will remain a recognized representative of the highest level for the remainder of his life. Should his life be cut short due to anything other than natural causes his legitimate heirs or assignees will hold his position in trust. As the original property owner and creator of this process, "The Head Cheese, CEO", shall remain the only recognized seller of original properties on this celestial body.

### Article 2

"The Head Cheese, CEO," and the then elected representatives of the Galactic Government shall be of the people, for the people and by the people. The primary responsibility of the Galactic Government shall be to help the citizens of Moon confidently pursue freedoms including but not limited to those listed in Number 1 of the Bill of Rights. "The Golden Rule" shall prevail. "Do unto others as you would have them do unto you."

### Article 3

Until the ratification of the Constitution Bill of Rights by the participating property owners and citizens of the Moon, "The Head Cheese, CEO", shall remain Omnipotent and will make changes to the Constitution/Bill of Rights as needed to insure the pursuit of our inherent democratic freedoms. The Lunar Embassy will remain as the organisation of choice by "The Head Cheese, CEO", and used to facilitate all changes and matters of Government with regard to the Constitution/Bill of Rights.

### Article 4

Under the provisions of this legal instrument, no one shall have the right to create a business from the selling of any acquired, purchased, or gifted lands offered originally by the Lunar Embassy where the purpose is to create a for profit venture without the express written consent of the Lunar Embassy. Violation of this article will result in revocation of any acquired, purchased, or gifted lands without compensation.

### Article 5

There are to be no use of weapons permitted on any planetary bodies covered by the original "Declaration of Ownership", by "The Head Cheese-CEO". These planetary bodies include, The Moon of Earth, Mercury, Venus, Mars, Jupiter, Saturn, Neptune, Uranus, Pluto and all their moons respectively. Anyone bringing or having weapons brought to them shall lose their right to property ownership and will be subject to expulsion to Earth. All monies paid for properties and improvements made will revert back to the Lunar Embassy without compensation to the expelled. There will be no exceptions to this rule. All utensils used for working, cooking, building etc. will be considered tools unless used in an act of violence against any resident, visitor, or citizen at which time the items will be considered weapons.

### Article 6

Any person(s), company(s), government(s), using the Moon for storage of their expended articles such as, explorative vehicles, batteries, space vessels, building supplies, crashed orbital devices, garbage or any other expended items will first lose possession of said item and secondly, will receive from the Lunar Embassy, with the blessing of the Galactic Government, a substantial fine. Said fine must be paid within 30 days of receipt or permission to visit or return to the Moon will be revoked permanently.

### Article 7


Even after the ratification of the Constitution/Bill of Rights by the property owners and citizens, only "The Head Cheese-CEO," will be allowed to declare war on any landlord, beings, other planetary governments or space entities. The Galactic Government must abide by this rule also.

### Article 8

As the recognized originator of the celestial property being sold, The Lunar Embassy will have the right to create the appropriate licensing and sale of that licensing for communications, utilities, building permits, taxes, government contracts, waste disposal, construction, banking, stock exchanges, patents, trademarks, copyrights, and all needed revenue for infrastructure construction until 2030 AD. For these services the Lunar Embassy will retain 25% of all revenue collected for these licenses to be turned over to the Galactic Government. The remaining 75% will be used by the Lunar Embassy for projects needing venture capital assistance. The Lunar Embassy will be held unencumbered in the decision making process for the development and spending of these generated monies.

### Epilogue

After designing and witnessing this document initially on the DAY OF LUNAR INDEPENDENCE, November 22, 1980 AD and having revised said document on September 27, 2000 AD, and again on September 21, 2001, I Dennis M. Hope, "The Head Cheese-CEO," do hereby submit this Constitution/Bill of Rights to my loyal subjects.
